- 1. THAT the proposed name of the corporation for which incorporation is hereby sought is "Squash PEI Inc.".

- f) To conduct clinics and other programs leading to the development and participation of the residents of Prince Edward Island in squash;
- g) To promote and assist in maintaining standardization of squash facilities;
- h) To have all the powers set out in the Companies Act of Prince Edward Island, R.S.P.E.I. 1988, C-14 and amendments thereto.
- 4. THAT the head office and principal place of business of the proposed Corporation shall be at Sport PEI, 3 Queen Street, P.O. Box 302, Charlottetown, C1A 7K7, in Queens County, in the Province of Prince Edward Island.
